This two-day course is designed to help you build a solid foundation to address and understand compliance and management issues as they relate to long-term care. The primary focus of this course is comprehensive care. Appropriate updates and guidance will be shared. The course is being held as a joint association training between Hoosier Owners & Providers for the Elderly and LeadingAge Indiana.

In September 2016, the Centers for Medicare & Medicaid Services (CMS) released revised Requirements for Participation under the Medicare and Medicaid Programs; Reform of Requirements for Long-Term Care Facilities rule. CMS has now revised Interpretive Guidance to be effective November 28, 2017.

All tags have been re-numbered and re-organized. This session will address the new information "tag-by-tag" for a comprehensive review of the revised Requirements as well as corresponding Interpretive Guidance.

**Session Content:**

- ✓ An introduction to the regulatory process, beginning with an overview of the Federal regulations and corresponding State rules.
- ✓ Emphasis will be placed on common compliance concerns and means to maintain compliance.
- ✓ If time permits, a review of the Quality Indicator Survey (QIS) process, Plans of Correction, and Informal Dispute Resolution
- ✓ Explanation of enforcement process will be provided.
