### OIG's New Approach to Compliance

- New healthcare program guidance issued November 2023
- OIG website rather than Federal Register
- Opportunity for feedback on individual industry-specific guidance
- Positive and negative of non-compliance list of risks
- Importance of policy review and risk assessments

### Medicare/Medicaid Affiliation

- Phase 1 (November 2019) CMS searching for "triggers" of "disclosable events"
- Searching for undue risk of fraud, waste, or abuse
- Deny or revoke enrollment and bar re-enrollment for up to 10 years
- Expansion of disclosable information for nursing facilities





### Heightened Scrutiny of SNF Transactions

- CMS raised SNFs from "low" to "high" categorized risk
- Both for-profit and nonprofit
- November 2023 "Transparency in Nursing Home Oversight"
- State law for hospital transactions







## Increased MFCU Investigations

- Patient accounts
- Drug mishandling and diversion
- Abuse and neglect and IJ survey findings
- Self-reported incidents
- Convictions, recoveries, civil settlements, and exclusions











### **DOJ National Nursing Home Initiative**

- March 2020 Coordinate and enhance civil and criminal efforts directed at grossly substantive care
- Use of Federal False Claims Act
- Staffing, infection control, food, pain medication and physical or chemical restraints



### **Exclusions from Medicare/Medicaid**

- Mandatory and permissive exclusions
- Broad coverage
- Importance of regular OIG Exclusions List checks
- Areas for confusion/deception
- Impact for facility





# Data Breach, Privacy and HIPAA Enforcement

- Breaches reported to OCR
- Settlement payments
- Indiana data breach reporting law
- Increased Indiana Attorney General investigations and enforcement actions





# Televski Decision

- Facts Why so important?
- Implications for damages claims
- Implications for Indiana









### **ADA + Sufficient Staffing**

- ADA as source for regulatory and civil liability
- Meeting needs of residents
- Staffing standards floor or celing



### **Granny Cams/Electronic Monitoring**

- Many states adopting standards (not Indiana)
- Common statutory features
- Importance of policy
- Security video cameras
- Cell phones/cameras





# CMS Minimum Staffing Standards

- 24/7 Registered Nurse requirement
- Minimum RN and Nurse Aid Staffing
- Implementation dates
- Costs and feasability
